

**TOWN COUNCIL OF CENTREVILLE
RESOLUTION NO. 14-2014**

A RESOLUTION establishing rates for the opening and closing of graves in the Chesterfield Cemetery, to provide for the collection of charges, providing a set up for cremation services and a concrete urn vault.

WHEREAS, the Town Charter gives the Town Council of Centreville the power to regulate and control the Chesterfield Cemetery.

WHEREAS, Section 42-3.B of the Town Code authorizes the Town to do interments.

SECTION ONE; AND BE IT FURTHER RESOLVED that for opening any grave or burial space in Chesterfield Cemetery, on weekdays (Monday Through Friday) except Holidays, the charge shall be:

- A. Stillborn remains _____ \$525.00
- B. Cremated remains _____ \$525.00
- C. Interment of a body at regular depth _____ \$700.00
- D. Interment of a body at double depth _____ \$950.00
(Providing for subsequent burial in same burial space)
- E. There will be an additional fee of \$50.00 per hour past normal weekly working hours of 8:00 AM to 4:00 PM and when a town employee is required to be available.

SECTION TWO; AND BE IT FURTHER RESOLVED that for opening any grave or burial space in Chesterfield Cemetery, on weekends (Saturday and Sunday) and Holidays, the charge shall be:

- A. Stillborn remains _____ \$525.00
- B. Cremated remains _____ \$525.00
- C. Interment of a body at regular depth _____ \$960.00
- D. Interment of a body at double depth _____ \$1210.00
(Providing for subsequent burial in same burial space)

SECTION THREE: AND BE IT FURTHER RESOLVED that the following prices shall be charged for burial spaces (price covers required corner posts) in Chesterfield Cemetery, to wit:

- A. For each Regular Space _____ \$700.00
- B. For each triangular cremation space (If available) ____ \$250.00
- C. Concrete Urn Vault _____ \$250.00

SECTION FOUR: AND BE IT FURTHER RESOLVED that all burial lots and spaces in Chesterfield Cemetery sold shall be for the cost thereof entitled to perpetual upkeep and care and fifty percent (50%) of the purchase price of such burial spaces shall become and be part of the perpetual care funds of the Chesterfield Cemetery Department.

SECTION FIVE: AND BE IT FURTHER RESOLVED, that there shall be a \$60.00 permit fee for all monuments installed. Said monuments must be installed on a two foot deep foundation, the location of the foundation to be approved by Town personnel. All preparation and notification to the Town for placement of monuments is the responsibility of the space owner(s).


SECTION SIX; AND BE IT FURTHER RESOLVED that the fee for providing cremation services which includes tent, greens, 6 chairs and a stand shall be \$400.00.

SECTION SEVEN: AND BE IT FURTHER RESOLVED that there shall be a \$15.00 fee for administration staff to look up Archived Records.

READ AND PASSED THIS fourth day of September, two thousand and fourteen.

BY ORDER: We hereby certify that Resolution Number 14-2014 is true and correct and duly adopted by the Town Council of Centreville, Maryland.


