ORDINANCE NUMBER 04-2016**

**AN ORDINANCE OF THE TOWN COUNCIL OF CENTREVILLE TO AMEND CHAPTER 20,  
BOARDS, COMMITTEES AND COMMISSIONS, OF THE TOWN CODE TO ALLOW FOR  
ADDITIONAL MEMBERS ON THE PARK ADVISORY BOARD AND THE TREE BOARD.**

WHEREAS, the Town Council of Centreville is authorized by §5-202 of the Local Government Article of the Maryland Annotated Code to pass ordinances that the Town Council deems necessary to protect the health, comfort and convenience of its citizens; and

WHEREAS, Section 301(a) and Section 301(b)(43) of the Charter of the Town Centreville authorizes the Town Council to pass ordinances that the Town Council deems necessary to protect the health, comfort and convenience of its citizens including to establish and maintain public parks, gardens, playgrounds and other recreational facilities; and

WHEREAS, citizens have expressed interest in serving on the Centreville Park Advisory Board; and

WHEREAS, pursuant to Section 20-10 of the Town Code, the Centreville Park Advisory Board is limited to five members;

WHEREAS, pursuant to Section 20-17, the Centreville Tree Board shall be the Centreville Park Advisory Board;

WHEREAS, the Town Council of Centreville wishes to have the flexibility to increase the membership on the Centreville Park Advisory Board and accordingly the Centreville Tree Board, but without a specific limit prescribed by Code.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of Centreville:

**SECTION ONE.** Chapter 20, Article III of the Centreville Town Code is hereby amended as follows:

**Article III. Park Advisory Board**

**§ 20-10. Membership; appointment; term; compensation.**

The Centreville Park Advisory Board shall be composed of five such number of members as the Town Council shall deem appropriate and appoint and who shall serve without compensation and who shall be selected from the citizenry of the Town by the Town Council to serve a three-year term of office; ~~except that, of the members appointed for terms beginning on February 7, 1985, two shall be appointed for three years, two shall be appointed for two years, and one shall be appointed for one year and until their successors have been appointed.~~

**SECTION TWO.** Chapter 20, Article IV of the Centreville Town Code is hereby amended as follows:

**Article IV. Tree Board**

**§ 20-17. Membership; by laws; meetings.**


- A. The Centreville Tree Board shall be composed of the ~~five~~ members who serve as the Centreville Park Advisory Board.

- B. The ex officio, nonvoting members of the Park Advisory Board shall also serve the Tree Board in that capacity.
- C. The officers of the Park Advisory Board shall also serve the Tree Board in that capacity.
- D. The Board shall establish bylaws for the conduct of its activities. It shall meet regularly at a time and place it shall establish.
- E. The Town Manager shall maintain records of the Board's proceedings and assist the Board with dissemination of information and other administrative duties as may be assigned by the Board.


